GreenFee Super 15-0-0 is a formulation of essential iron, sulfur and nitrogen. Super 15-0-0 is compatible with most pesticides and fertilizers (with the exception of amino formulations and high phosphate fertilizers).

DIRECTIONS FOR USE: Greens, Tees, Fairways, Athletic Fields, Lawns and other Turf Areas. Apply 3 oz. to 6 oz. of GreenFee Super 15-0-0 in a sufficient amount of water for thorough coverage (usually 2.5 gal. per 1,000 sq.ft). 3 oz. of GreenFee Super 15-0-0 per 1,000 sq.ft. supplies 0.03 lbs. N per 1,000 sq. ft. GreenFee Super 15-0-0 is best applied when the turf is actively growing. Apply monthly or as needed to maintain turf color. For best results, avoid watering for 24 hours after application. This product should be used as a supplement to a regular fertility program. GreenFee Super 15-0-0 will not by itself provide all the nutrients normally required by plants.

SHAKE WELL BEFORE USING! A pre-mix jar-test is recommended to check compatibility of product combinations that have not been previously tested.

HANDLING & STORAGE: Store between 40-95°F (4.44 - 35°C). Avoid direct heat or fire. Decomposition may occur at high temperatures (above 225°F/107°C). Do not freeze.
